The second year of SEEK Birmingham will take place June 6-24, 2016! Students in grades 3-5 have been welcomed on the

Phillips Academy campus to take part in this free S.T.E.M. program. Phillips Academy is located at 2316 7th Ave N, Birmingham, AL 35203.

The SEEK Program is designed to be a fun and engaging educational experience, led by NSBE engineering students and technical professionals dedicated to pursuing professional excellence and giving back to the community. Students work in teams to solve problems and create products while discovering the underlying math and science principles involved in these processes. Each week, the students take on a new project, culminating with a presentation, design competition and physical competitions.

The projects for this year are:

#### Catapult:

Students have the opportunity to construct a medieval trebuchet from balsa wood. Students will design and experiment with different counterweights and lever lengths, all the while learning the mathematics that apply to moving projectiles. The students will also learn concepts like horizontal and vertical motion as well as energy transfer. Provided by Society of Automotive Engineers (SAE) International, A World In Motion (AWIM)

#### Wind Turbine:

Students focus on how wind energy can be generated on both a large and small scale. Student teams design and build a working wind turbine out of everyday products and learn about anemometer as well as site testing. As wind energy continue to grow in the energy market, it's vital that the students become exposed to clean alternatives for fossil fuels.

#### **Snaptricity:**

Students have the opportunity to design and construct fully operating circuits using Snaptricity kits. As students delve into the world of electrical engineering, they learn about resistance, current, and Kirchhoff's Laws.

### 2016 NSBE-BHAM E-Board Election Process



Any active member of the NSBE-BHM chapter is eligible for an elected office. An active member is someone whose dues are current at the time of election.

All active members will receive nomination and election emails. Nomination and election surveys may not be shared with inactive members.

Nominations will be accepted until June 10, 2016 at 5 PM.

Elections will run from June 20-24, 2016. Election results will be published by June 30, 2016.

The duties of the elected and appointed officers are:

#### (a) President

- Shall preside over all official meetings of the NSBE-BHM Chapter
- Shall serve as a representative of the NSBE-BHM Chapter
- Shall appoint standing and special committee chairpersons with advice and consent of the Executive Officers, except where otherwise provided for in this document
- Shall administer the Constitution, Bylaws, policies, and procedures of the National Society of Black Engineers and the NSBE-BHM chapter
- Shall render reports and accounting to the General Membership, the Chapter Executive Board, and National Office as required by the National Operating Guidelines
- Shall have the general powers and duties of management usually invested in the office of President or Chair

#### (b) Vice-President

- Shall preside in the absence or inability of the President
- Shall perform any activities, duties, and responsibilities as designated by the President
- Shall oversee the activities of the standing committees
- Shall be an ex-officio member of all standing committees
- Shall render reports and accountings to the General Membership, the Chapter Executive Board, and National Office as required by the National Operating Guidelines

#### (c) Communications / Secretary

- Shall fill and countersign all certificates issued and keep and make proper entries in the books of the chapter.
- Shall serve all notices required by the Bylaws
- Shall record accurately the minutes of all meetings of the General Membership and the Executive Board and make available the minutes to all members upon request
- Shall maintain a copy of the most updated version of the Constitution, Bylaws, and Standing Rules of NSBE and the local chapter
- Shall render reports and accountings to the General Membership, the Chapter Executive Board, and National Office as required by the National Operating Guidelines
- Shall provide communications to the General Membership in the forms of newsletter, social media, and via the chapters website

#### (d) Treasurer

- Shall keep accounts and deposit funds for the chapter.
- Shall ensure that expenditures made for chapter business; be in a manner approved by the Executive Board.
- Shall maintain the membership roll and collect annual dues of the chapter.
- Shall render reports and accountings to the General Membership, the Chapter Executive Board, and National Office as required by the National Operating Guidelines.
- Shall ensure on a periodic basis or at least at the end of the fiscal year, the book of accounts be audited in a manner prescribed by the Executive Board.
- Shall, on approval of the Executive Board, disburse funds listed in the approved budget and those funds not listed but are necessary to maintain operations of NSBE-BHM.
- Shall be an ex-officio member of the Finance/Fundraising Committee.

#### (e) Parliamentarian:

- The parliamentarian advises the president and other officers, committees, and members on matters of parliamentary procedure. The parliamentarian's role during a meeting is purely an advisory and consultative one – since parliamentary law gives to the chair alone the power to rule on questions of order or to answer parliamentary inquiries
- During a meeting, the work of the parliamentarian should be limited to giving advice to the chair and to any other member with permission of the chair.
- It is also the duty of the parliamentarian

   as inconspicuously as possible to call
  to the attention of the chair any error in
  the proceedings that may affect the
  substantive rights of any member or
  may otherwise cause harm.
- The Parliamentarian shall chair the elections committee as appointed by the Executive Board. The elections committee, under guidance of the Parliamentarian, will compile and disseminate documents and procedures to members seeking office and will coordinate the election.

#### (f) Committee Chairs

- Shall be appointed by the chapter president
- Shall execute the duties of the committee
- Shall render reports and accountings to the General Membership, the Chapter Executive Board, and National Office as required by the National Operating Guidelines

There shall be four (4)-standing committees of the NSBE-BHM chapter, which are:

<u>Finance:</u> The primary responsibility of the Finance committee is to identify, secure, and maintain new and existing financial resources for the chapter. In addition, the committee responsibilities include:

- Shall prepare a budget for the fiscal year and submit to NSBE-BHM at the August meeting
- Preserve financial relationships with sponsors
- Shall submit amendments, if necessary, to the budget for the current fiscal year, which may be adopted by a majority vote of the membership
- Develop and maintain a Corporate Solicitation Packet
- Be responsible for solicitation of operating funds from Corporate Sponsors
- Shall audit the book of accounts on an annual basis

<u>Fundraising</u>: The primary responsibility of the fundraising committee is the development, coordination, and execution of all chapter fundraisers. In addition, the committee responsibilities include:

- Shall plan and organize the Annual Scholarship and Awards Banquet and is the central committee for all activities related to the banquet
- Shall plan and organize the Annual Scholarship Golf Classic and is the central committee for all activities related to the golf classic
- Shall develop, plan and organize any additional chapter fundraising activities and is the central committee for all activities related to fundraising
- Shall work closely with the finance committee in coordinating fundraising activities

 Shall work closely with the communications committee in promoting fundraising activities

Membership/ Programs: The primary responsibility of the membership committee is the recruitment and retention of Professionals Members. In addition, the committee responsibilities include:

- Devise and/or coordinate membership and recruitment activities and socials
- Shall process membership applications into NSBE-BHM
- Shall welcome and orient new NSBE professionals members into NSBE-BHM
- Shall focus on membership retention
- Develop and coordinate the chapter directory
- Shall submit to NSBE-BHM for its approval at its regular meeting in August the annual program of NSBE-BHM.
- Shall develop and coordinate the programming of quarterly General Body Meetings
- Shall develop and coordinate innovative programs to fulfill the directives of NSBE and NSBE-BHM

Pre-College Initiative (PCI): The primary responsibility of the PCI/CI committee is to develop programs that utilize the talents of NSBE Professionals Members in mentorship or other interaction with pre-college students at any grade level, undergraduate students, and graduate students in and around the Birmingham metropolitan area. In addition, the committee responsibilities include:

- Develop and implement innovative programs to stimulate the interest of our youth in the fields of science and technology
- Shall promote technical education and
  careers
- Shall enhance the availability of scholarships to technical minority students
- Shall act as an interface, resource, and support system for NSBE student chapters in and around the Birmingham Metropolitan area
- Shall interact with academia from high school to graduate school and serve as the Chapter liaison for those institutions
